Does not pertain to subcommittees, The CTN board believes committees should run their own design and the board should support, not dictate any committee rules.
		Vote was called. In person all present raised arm indicating yes, there were zero no's. Online zoom poll received 54 out of 68 replying Yes. There were zero no's. The amendment passed. The approved CTN bylaws will be available on the CTN website.
