- **TSN Brainstorm**
- Erin Hart: TSN program coordinator at UCHealth Aurora Campus
 - o Reported that at the Aurora Campus TSN has picked up speed over the last year

- Completed the TSN handbook
- Every other week they do a mobile cart (every other Thursday) provide coffee, snacks, and mental health resources to patients
- Recently started a support group offered to patients and families, meets once a month
 - 7 participants last month
 - Specific support group expansion in the future? – older adults, caregivers, etc
- Trauma Survivor Day – community art project
 - Patients, families, and staff to add a mosaic as part of a table/tulip in the waiting room
 - Race to rebuild – one event for the entire community

National Injury Prevention Day Next Friday November 18

- 5 categories for injury prevention topics to gather feedback
- Our group reached out and asked questions on how the program was impactful
- Lori Morgan – struggling to share information in chat meetings
- Laurie – shared with the center for injury and violence prevention
 - They would get it up on their website and social media
 - Up on CTN website – main page and injury prevention page
 - Social media – requested that people go on and follow the CTN

SEMTAC Prevention Committee

- Quarterly EMTS-IP committee was a meeting of the SEMTAC
- IP had always been a part of this meeting
- The meeting that we had was technically created when CDPHE got money and was required to have a steering committee
 - CDPHE no longer has that funding and didn't need to continue the steering committee
 - It was decided by SEMTAC that it would become the prevention committee officially run under SEMTAC – voted in chairs (must be SEMTAC members)
 - Chairs voted in
 - **Discussion around expanding the scope of the committee to address medical based things in addition to injury prevention**
 - **Our Committee has concern that we might lose this space to collaborate**
 - There's a lot of people on that call – this is their avenue for getting information on what's happening in the state
 - How can we keep IP at the forefront – we as a group need to be more vocal about what we want

- What is EMTS-IP
 - Sharing information from the state level – would like to see it continue
- How do we want to stay engaged at the state level?
 - We need to own this
 - State-wide data and county level data from CDPHE
 - Maintain the education component of this meeting
 - EMS, rural folk who were able to pull some of the state information
 - Want to maintain the opportunity to collaborate
 - STB DIA – through the CTN-IP
 - With EMS on falls prevention
 - Stay in the loop on grant opportunities at a national level that the State can become involved in
